Section 2 Proposed Warm Water Pool

The Warm Water Pool facility will include two pools for community use and clinical rehabilitation and programs, as well as allied health services like physiotherapy and occupational therapy. It will provide opportunities for all in the community to benefit from warm water exercise, including learn to swim.

It will be a public facility with a fee structure set by Council to ensure it is affordable for people on pensions and with low incomes. The facility will be carefully designed to be accessible for people of all abilities, including changerooms and other features for people with high and complex needs.

Community feedback on the design, specialised supports and fee structure will be sought in future rounds of engagement should the proposal progress to the next stage.

The Warm Water Pool would be designed, built and funded by Council at a cost of approximately \$15-\$18 million.

It is proposed that the Wellness Centre facility will include indoor and outdoor mineral hot springs and plunge pools, a spa and sauna, snow room and reflexology walk and a range of related rejuvenation services and programs.

The facility would initially be a private facility, leased and operated by Leisure Management Services (LMS - the current lessee of Brighton Golf Course). At the end of the lease period, ownership will be handed to Council. The facility will meet all contemporary accessibility standards.

The Wellness Centre would be designed, built and funded by LMS.

# Section 4 Proposed Site at Brighton Golf Course

After a detailed site assessment process, Council has selected the north-east corner of the Brighton Golf Course as the preferred site for the Warm Water Pool. This is due to its central location, access via road and bus, lesser environmental impact, ability to meet expected parking requirements and proximity to a large proportion of people aged over 60 years.

To accommodate the Wellness Centre next to the Pool, LMS has proposed a careful realignment of the golf course, maintaining its par 67, and a new indoor specialist golf training and coaching facility.

Over 500 new trees would be planted to offset the removal of some existing trees and vegetation. The proposed facilities will also use innovative energy management techniques to align with our Climate Emergency Action Plan and commitment to carbon neutrality.

The Wellness Centre will initially be a private facility for bathing, relaxation and rejuvenation. It will be designed, built and funded by LMS. LMS will also invest in a realignment of the Golf Course, a new indoor specialist golf training and coaching facility, and other course improvements.
